### **Your Guide to Family Leave Insurance in New Jersey**

If your employer requires you to use up to two weeks of sick leave, vacation time, or other paid time off, the maximum Family Leave Insurance allowance may be reduced by up to 14 days If you claim family leave benefits to care for a family member with a serious health condition, you must give your employer reasonable advance notice unless:
